

i. Procedure

Application form along with complete documents along with visa fee slip* can be submitted either personally at the Embassy otherwise, the applicants have the option to submit through our respective Consulates in Karachi, Lahore, and Peshawar or through our drop-box service providers listed as:

- Gerry's International located at Islamabad, Peshawar, Lahore, Gujranwala, Faisalabad, Multan, Sialkot, Karachi, Hyderabad, Quetta, Sukkur.
- Omar Travels, Blue Area. Islamabad.
- Sasha International, G-7 Markez, Islamabad.

Note: Drop-Box Service charges are applicable per application payable to Drop-Box only in addition to the visa fee.

ii. Interviews:

Prior to the issuance of visa, it is mandatory for the applicants applying for the visa to have a personal appearance at the Embassy. The Consular Section shall interview all visa applicants. Applications submitted through Consulates/Drop Box providers shall be contacted via telephone by the Embassy for scheduling of the interviews. While applicants appearing personally at the Embassy with their complete documents shall be entertained for submission and same day interviews from Monday-Thursday 10.00am-12.00 pm.

iii. Process Time:

After personal interview & submission of complete documents, processing time for Tourist/ Business visas is 15 working days while the Ministry of Brazil shall process other visa applications in their own time.

* Note: Granting of an entry visa in Brazilian territory is a sovereign and discretionary act of State; therefore, submission of complete visa application and interview does not guarantee the issuance of visa. Before applying for a visa, check our [General Information on Visas](#).

Documents must be written in Portuguese or in English.

Important: Documents from Pakistan and other countries must be original and attested by the Ministry of Foreign Affairs, as described below.

Brazilian documents must be notarized by a Notary Public in Brazil.

Additional documents and information may be required by the Consular Section, if deemed necessary.

All applicants will be submitted to an interview.

Tourist Visa (VIVIS)

1. Who can apply

Foreigners who wish to visit Brazil for short term with no intention to migrate or work there.

2. Documents required

- Visa application [form](#) filled online, with passport-sized picture pasted onto it.
- Valid passport.
- Original Bank Deposit Slip.
- Birth Certificate (if not married) or Marriage Certificate (if married), attested by the Ministry of Foreign Affairs
- Original FRC (Family Registration Certificate) attested by Ministry of Foreign Affairs
- Copy of passport on A4-size paper (please, do not cut down to size)
- Original Police Character Certificate attested by the Ministry of Foreign Affairs
- Hotel reservation
- Traveling schedule
- Bank statement of last six months along with bank letter
- Employment letter and Visa Request Letter
- Participants of academic conferences, seminars and congresses must provide invitation letter from the organization that is sponsoring the event.
- Minors under 18 years of age are required a notarized letter of consent by the parent not traveling with the minor, or by both parents if the minor is traveling alone.
